INTRODUCTION

En 1853, B. Langenbeck a été le premier à décrire un élargissement du processus coronoïde mandibulaire chez un patient (1). En 1899, l'anatomiste français O. Jacob a décrit la présence d'une articulation non fonctionnelle entre le processus coronoïde de la mandibule et l'arcade zygomatique, entraînant une limitation de l'ouverture de la bouche (2). Les causes d'élargissement du processus coronoïde rencontrées sont l'ostéochondrome, l'ostéome, l'exostose osseuse ou l'hyperplasie (3,4). Même s'il existe des différences entre les maladies de Langenbeck et de Jacob en termes d'étiologies, les signes cliniques retrouvés, l'impact sur la vie du patient et leur prise en charge chirurgicale sont similaires.

L'incidence de ces maladies est encore inconnue. Cependant, les maladies de Jacob et de Langenbeck semblent toucher plus souvent les hommes (63%) à un âge moyen de 30 ans, allant de 5 à 73 ans (5). Les pathologies sont souvent présentées comme des cas bilatéraux (6). L'étiologie de l'hyperplasie coronoïde est encore mal connue. Plusieurs hypothèses ont été avancées, telles que des causes développementales et génétiques (7), une suractivité des muscles temporaux (8), un traumatisme osseux (9), des influences endocriniennes (6,10,11) ou des troubles de l'articulation temporomandibulaire (ATM). La plupart du temps, la maladie est considérée comme idiopathique.

Les signes cliniques courants de ce conflit du processus coronoïde sont représentés par une limitation d'ouverture buccale progressive et indolore, une asymétrie faciale causée par un gonflement en regard de l'arcade zygomatique et des troubles de l'articulation temporomandibulaire (12,13). Tous ces symptômes peuvent avoir de graves répercussions sur l'hygiène buccale et la qualité de vie des patients (14). Le traitement chirurgical le plus souvent appliqué est la coronoidectomie par une approche intra- ou extra-orale. (15) La technique intra-orale vise à sectionner le processus coronoïde mandibulaire hypertrophié par une incision vestibulaire, suivie d'un fort décollement de l'insertion du muscle temporal. L'approche extra-orale par lambeau coronal reste indiquée en cas d'hypertrophie sévère des processus coronoïdes dépassant l'arcade zygomatique jusqu'à la fosse temporale. (16) Cette technique présente un risque de cicatrices

externes et un risque de lésion de la branche frontale du nerf facial. Malgré l'efficacité immédiate de la coronoidectomie en ce qui concerne l'ouverture buccale dans la plupart des cas, la récurrence de cette limitation peut être observée chez 2% des patients. (5) Plusieurs causes peuvent être responsables de cette récurrence, comme le développement d'une nouvelle formation osseuse sur le processus coronoïde ou une fibrose musculaire du muscle temporal.

À notre connaissance, il n'existe aucune publication rapportant la récurrence de la limitation d'ouverture buccale chez des patients traités chirurgicalement pour les maladies de Jacob et de Langenbeck. Goh et al (6) ont étudié 115 cas d'hyperplasie coronoïde opérés par coronoidectomie (toutes causes confondues). On peut calculer un taux de 12% de récurrence de limitation d'ouverture buccale chez ces patients. Malheureusement, les causes de récurrence et les moyens de prévention ne sont pas abordés dans cette revue.

L'objectif principal de notre étude était d'examiner l'ouverture buccale à long terme après une coronoidectomie chez des patients atteints de la maladie de Langenbeck ou de Jacob et d'étudier le risque de récurrence clinique et les facteurs pouvant influencer une récurrence de la limitation de l'ouverture buccale.

ABSTRACT

Langenbeck's and Jacob's diseases are rare causes of progressive mouth opening limitation due to the impact of hypertrophy of the coronoid process(es) on the zygomatic bone. This retrospective study included twenty patients with mouth opening limitation who underwent coronoidectomy. Contrary to the literature where recurrence rates ranging from 2 to 12% can be found and where clinical worsening can also be found in some patients, the postoperative follow-up of these patients showed that no clinical recurrence had occurred. The common point of these twenty patients was to continue physical therapy and self-rehabilitation. Although the standard treatment for these conditions is coronoidectomy, it seems important to consider the risk-benefit ratio of the patient and to operate only if the limitation of the mouth opening leads to a real clinical distress for the patient's quality of life.

INTRODUCTION

In 1853 B. Langenbeck was the first to report an enlargement of the mandibular coronoid process in a patient (1). In 1899, the French anatomist O. Jacob described the occurrence of a non-functional joint between the coronoid process of the mandible and the zygomatic arch leading to a mouth opening limitation (MOL) (2). Causes of enlargement of the coronoid process are represented by osteochondroma, osteoma, bone exostosis or hyperplasia (3,4). Even if there are differences between Langenbeck's and Jacob's diseases in terms of etiologies, clinical signs, and impact on the patient live, their surgical management is similar.

The incidence of these diseases is still unknown. However, Jacob's and Langenbeck's diseases appear to involve more often males (63%) at a mean age of 30 years, range from 5 to 73 years (5). The pathologies are commonly presented as bilateral cases (6). The etiology of coronoid hyperplasia is still poorly understood. Several hypothesis have been advanced, such as developmental and genetic causes (7), overactivity of the temporalis muscles (8), bone traumatism (9), endocrine influences (6,10,11) or temporomandibular joint (TMJ) disorders. Most of the time, the disease is considered as idiopathic.

The common clinical signs of coronoid process impingement are represented by a progressive and painless MOL, a facial asymmetry caused by a swelling with regard to the zygomatic arch and TJM disorders (12,13). All of these symptoms may have serious repercussions regarding oral hygiene and quality of life of the patients (14). The surgical treatment mostly applied is coronoidectomy through an intra- or an extraoral approach. (15) The intraoral technique aims at cutting the excessive mandibular coronoid process by a vestibular incision followed by the strong detachment of the insertion of the temporal muscle. Th extraoral approach by coronal flap remains indicated in cases of severe hypertrophy of the coronoid processes extending beyond the zygomatic arch up to the temporal fossa. (16) This technique raises the risks of external scars and potential injury of the frontal branch of the facial nerve. Despite immediate efficacy of coronoidectomy with respect to oral opening in most cases, recurrence of MOL can rarely be observed in 2% of patients. (5) Several causes may be responsible for this recurrence, such as the development of a new bone formation on the coronoid process or muscle fibrosis of the temporalis muscle.

To our knowledge, there is no publication reporting the recurrence of MOL in surgically managed patients with Jacob's and Langenbeck's diseases. Goh et al (6) studied 115 cases with coronoid hyperplasia operated on by coronoidectomy (all causes combined). A 12% rate of MOL recurrence in

these patients can be calculated. Unfortunately, the causes of recurrence and means of prevention are not addressed in this review, nor is the best protocol of care.

The main objective of our study was to examine long-term oral opening after coronoidectomy in patients with Langenbeck's or Jacob's disease and to investigate the risk of recurrence and factors that may influence a recurrence of oral opening limitation.

MATERIALS AND METHODS

Data collection

Patient affected by Langenbeck's or Jacob's disease and having received a unilateral or bilateral coronoidectomy were included in this multicenter, descriptive, retrospective study. We surveyed various French centers that have treated these diseases. To be included the values of patients' mouth opening had to be reported in their medical charts in the preoperative time and during the follow-ups after a minimum of 3 months after the surgical procedure. All the medical charts were reviewed and the data regarding the age, gender, side involved, date of the surgical procedure, type of approach for the coronoidectomy, and values of mouth opening during follow-up. The preoperative value was referred as M1, and the postoperative value as M2. Data related to the injection of botulinum toxin in the masticatory muscles, the active rehabilitation by a physical therapist, as well as self-rehabilitation were also reported.

Due to the retrospective nature of this study, it was granted in written an exemption of requiring approval from the ethics committee of the Nantes University Hospital, in accordance with the French legislation Article L. 1121-1 paragraph 1 and R1121-2 of the Public Health Code. All of the subjects or their guardianships provided their signed consent for use of data.

Statistics

For descriptive analysis, quantitative data were given as means and standard deviations (SD). Qualitative data were given as values and percentages. Histogram and Shapiro-Wilk test have shown that values distribution doesn't rely on a normal law. Then analyses were based on non-parametric test, Wilcoxon or Mann-Whitney tests, according to the dependence between the samples. A *p* value of 0.05 was defined as the threshold of statistical significance. We compared preoperative to postoperative MOL. All data were processed with Excel software (Microsoft Corporation. 2019. Microsoft Excel. Retrieved from <https://office.microsoft.com/excel>).

RESULTS

Twenty patients were included in this study between 2005 and 2022: nine patients were treated in the Nantes University Hospital, 11 came from the Lille University Hospital and 1 patient was treated in the Caen University Hospital.

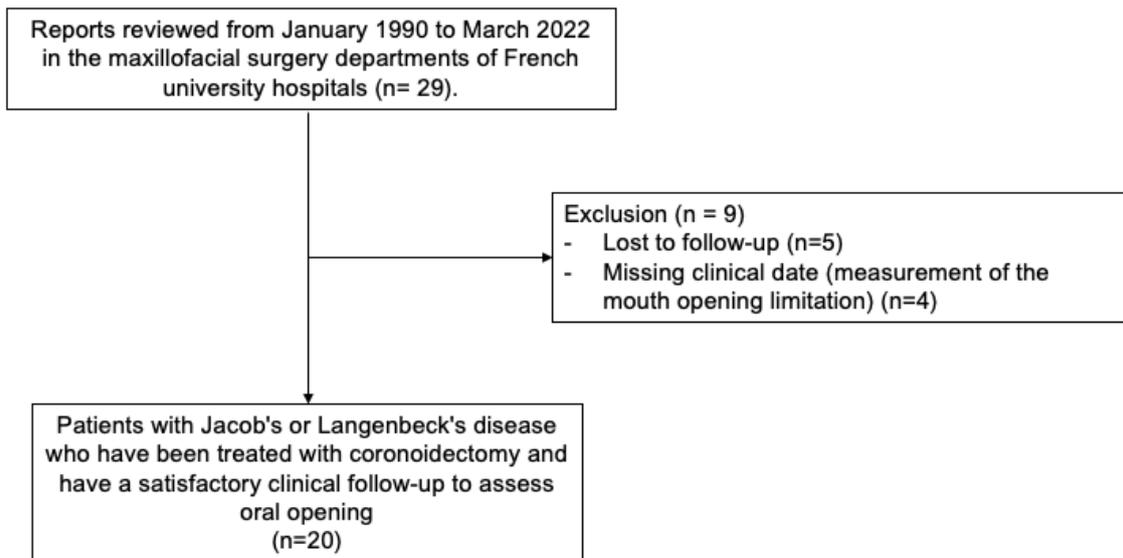


Figure 1: Flow chart of patient selection

Among the included patients in this case series, 6 were female and 12 were male (ratio: 2/1). The mean age at surgical management was 16.3 years, ranging from 6 to 28 years. Of these patients, 17 were diagnosed with Langenbeck's disease and 3 with Jacob's disease.

Mouth opening monitoring (Table 2, Figure 4)

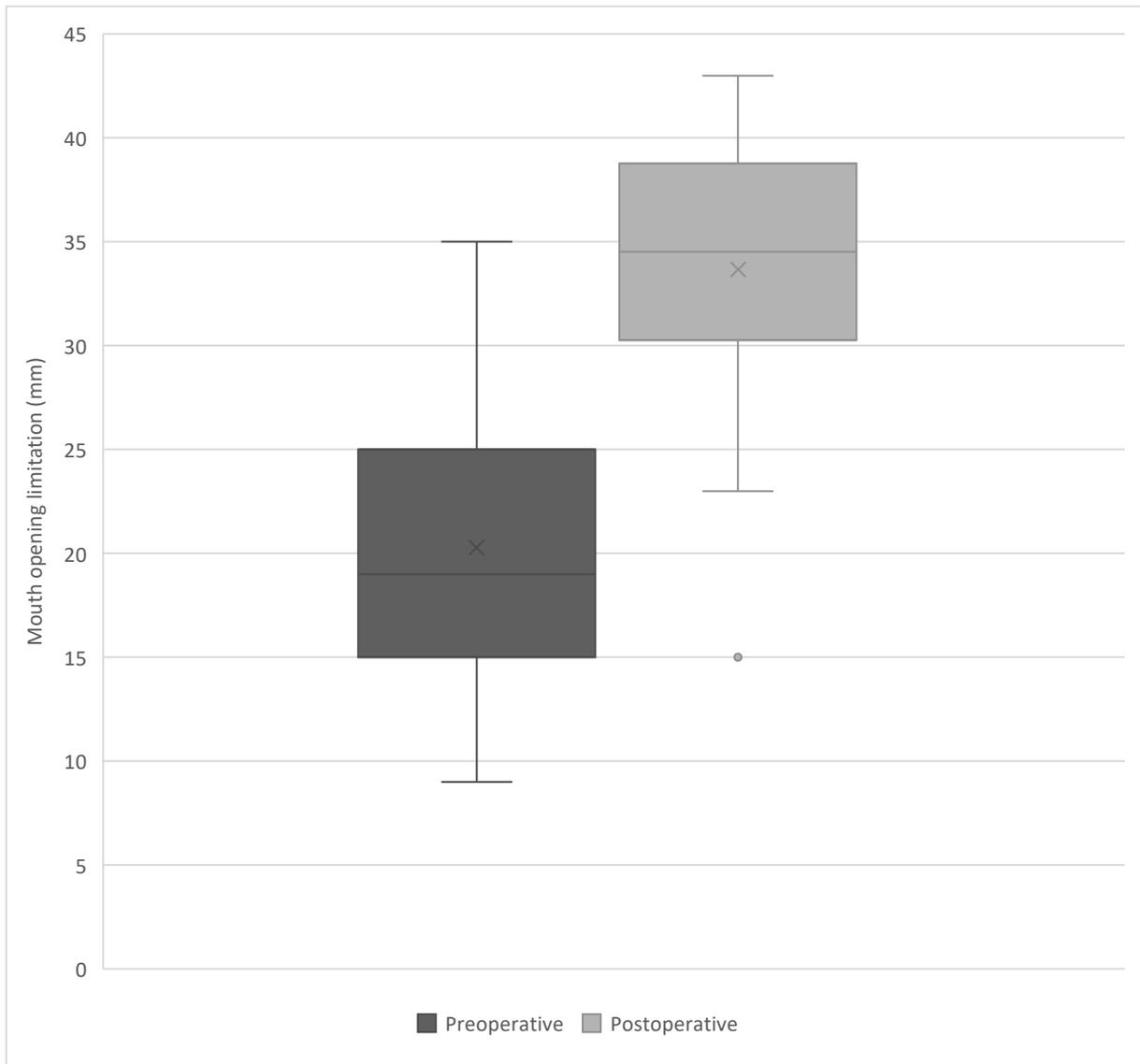
The MO was improved from 20.28 ± 6.66 mm in preoperative time to 33.65 ± 6.81 mm in postoperative period ($p < 0.0001$). However, clinical improvement was poor for two patients (#3 and #7) in who still reported difficulties with feeding and proper dental care.

The duration of postoperative follow-up was therefore disparate among patients; it ranged from 3 months to 14 years. The mean follow-up duration between the M1 and M2 measurements was 21.5 ± 40.5 months.

Therapeutic management of patients (Table 1, Figure 3)

A bilateral coronoidectomy was performed in 17 cases, while 3 patients required a unilateral procedure. Only one patient was given a mixed coronal and intra-oral approach due to the size of the coronoid process extending far above the zygomatic arch into the temporal fossa outside the orbit. All other patients required an intra-oral procedure.

We reported three cases of botulinum toxin injections in the masticatory muscles during the surgical procedure, with a mean of 40 IU in each temporal muscle. Two other patients received botulinum toxin injections in the main masticatory muscles postoperatively at one year after coronoidectomy. All patients received rehabilitation by a physical therapist, followed by self-rehabilitation training. This consisted of diduction, propulsion and mouth opening exercises. The self-rehabilitation consisted of the use of objects of increasing size to gradually increase the mouth opening. However, the frequency of sessions was not known for all patients.

Clinical cases

In patient #2, the diagnosis of Langenbeck's disease was evoked by the fact that his mouth opening was limited to 20 mm, which was disabling at the time and was detected by his dental surgeon. He underwent a bilateral coronoidectomy at the age of 12. The immediate postoperative mouth opening measurement was 40 mm. The patient performed self-rehabilitation with corks, but received no other adjuvant treatment. After fourteen years of follow-up, the mouth opening measurement was 38 mm. The patient has no complaints about his initial pathology to date.

Patient #7 has had multiple recurrences despite four coronoidectomies between 2001 and 2021. This patient has chronic mechanical limitation of mouth opening due to conflict of the coronoid processes with the zygomatic bone. After the first three procedures, an improvement in mouth opening was transiently noted. The patient's quality of life was impaired: eating was made difficult and dental care was complicated or even absent (loss of two molars due to carious lesions).

The last surgical procedure in 2021 consisted of a bilateral coronoidectomy through a coronal and intraoral approach under general anesthesia. Preoperative CBCT (Figure 2) showed a right coronoid process of more than 28 mm, and a left coronoid process of more than 40 mm.

The immediate postoperative forced mouth opening was 25 mm. In addition, the patient received botulinum toxin injections into each temporal muscle body (40 IU per muscle). At the follow-up (three months) mouth opening was measured at 15 mm.

DISCUSSION

Due to the MOL, Jacob's and Langenbeck's diseases may have a clinical impact on the quality of life of patients. These pathologies strongly alter eating, chewing, phonation and oral hygiene.

These are rare diseases, poorly described in the literature with no precise prevalence value (18). Furthermore, most of cases are under-diagnosed because they are often initially treated as TMJ disorders (19). A prevalence of 0.5% has been reported for asymptomatic hyperplasia of the coronoid process (3,19). It can therefore be assumed that the prevalence of symptomatic Langenbeck's and Jacob's disease is much lower. The treatment is based on a surgical unilateral or bilateral coronoidectomy to resect the hypertrophic coronoid process and release the temporal insertions to improve mouth opening. However, this treatment has not been evaluated in terms of improvement of the mouth opening and the risk of recurrence. Other treatments have been described to limit the risk of recurrence and improve joint amplitudes; they are based on physical therapy, injection of botulinum toxin in the masticatory muscles. A recurrence rate of 2% has been reported in the literature (19). However, the concept of recurrence seems to cover only the new bone growth of the coronoid process(es), but does not address the clinical symptomatology represented by the oral opening measurements, as studied here. Yet it is the clinical symptoms that are the focus of patients' concern.

This study is the first to focus on the evaluation of oral opening after coronoidectomy in patients with Langenbeck's or Jacob's disease. Twenty patients were studied in three different French centers, which reflects the extreme rarity of the pathology. We demonstrated no recurrence of mouth opening limitation after coronoidectomy. Within our 21.5 months evaluation period, we found no stagnation or clinical worsening of mouth opening among the 20 patients. It is important to note that all patients in our study were followed up for rehabilitation by a physical therapist or self-rehabilitation with exercises taught by the surgeon (use of the plug). Thus, the use of rehabilitation may explain the maintenance of a correct post-coronoidectomy mouth opening (16). In their literature review of 73 operated patients, Goh *et al.* found the absence of improvement in mouth opening in 2 patients and worsening in 7 patients (increased mouth opening limitation postoperatively). Thus, the authors reported 12% of cases presenting with a clinical recurrence of symptoms, without necessarily documenting bone regrowth of the coronoid processes. We did not observe any recurrence of mouth limitation after the surgical procedure. This review includes almost all cases with Langenbeck's and Jacob's disease operated by coronoidectomy found in the literature. Furthermore, the authors found an improvement in mouth opening from 16.52 ± 6.87 mm

preoperatively to 34.88 ± 13.91 mm postoperatively, which is very similar to our results. However, our observation period was longer than the literature review (21.5 ± 40.5 months vs 19.9 ± 22.9 months respectively).

Our study suffers from inevitable drawbacks. First, the retrospective nature of this study sometimes made it difficult to collect the clinical information and symptoms reported by the patients (pain, difficulty in eating and speaking). Postoperative imaging was not systematically performed, which made it impossible to calculate the kinetics of bone regrowth of the coronoid processes. Rehabilitation protocols were sometimes poorly reported. Second, because of the rarity of the disease and the fact that it is often confused with a TMJ disorder, the number of patients collected was small. However, our study reported the largest cohort of patients from Langenbeck and Jacob. Third, postoperative follow-up was sometimes short and did not diagnose recurrence of mouth opening limitation, which may occur later.

Given the risk of clinical recurrence, it is therefore essential to inform patients that they should only undergo surgery if the mouth opening limitation is severe and impacts their quality of life. Thus, the question arises as to what factors may influence the recurrence of mouth opening limitation in these conditions, as well as the correlation or dissociation between the recurrence of mouth opening limitation and bone regrowth of the coronoid processes. Numerous hypotheses can be formulated regarding the factors favoring anatomical recurrence and clinical recurrence. Indeed, during coronoidectomy, the formation of a hematoma opposite the resected process could induce an increased capacity for bone regeneration (11). Similarly, some studies have reported an involvement of growth hormones during puberty, related to an exaggeration of the normal growth pattern observed at this period (10). Finally, the initial surgical failure could be attributed to the continuous growth of the face, secondary to the young age of the patients (14). On the other hand, there is still no consensus on the use of botulinum toxin injections to limit the stresses exerted by the remaining temporal muscle fibers on the coronoid process. Some clinicians perform these injections at the end of the surgical procedure, some propose the injection of botulinum toxin during the follow-up. Similarly, the use of biphosphonates postoperatively has been reported in order to limit the risk of recurrence of growth of the coronoid process but has not been studied (20). de la Torre *et al.* suggested to maintain a continuous mouth opening postoperatively with a removable upper acrylic splint to limit fibrosis and trismus (17).

To go further, it would be necessary to understand more about the pathophysiology of Jacob and Langenbeck diseases.

An interest in the embryology of the coronoid process could help answer some of these questions. Indeed, during the embryological formation of the mandible, growth takes place in the three directions of space through the different skeletal units. In particular, the future mandibular apophyses are referred to as secondary cartilages (condylar and coronoid cartilages in particular). These secondary cartilages are under the influence of local factors. In this case, the coronoid cartilages are under the influence of the temporal muscles.

In the same way, the realization of a systematic assessment in affected patients could be relevant: performing a systematic imaging in the immediate postoperative period, looking for radiological signs (formation of a neo-articulation with the zygomatic arch, appearance of the condyle), biological workup, oral clinical examination that may reveal signs of bruxism by the presence of dental wear facets, palpation and search for hypertrophy of the temporal and masseter muscles, diduction values, and information regarding condylar growth disorders in very young patients. The answers to these questions seem complex and could be provided by massive data collection. Our data are interesting and pave the way for larger studies.

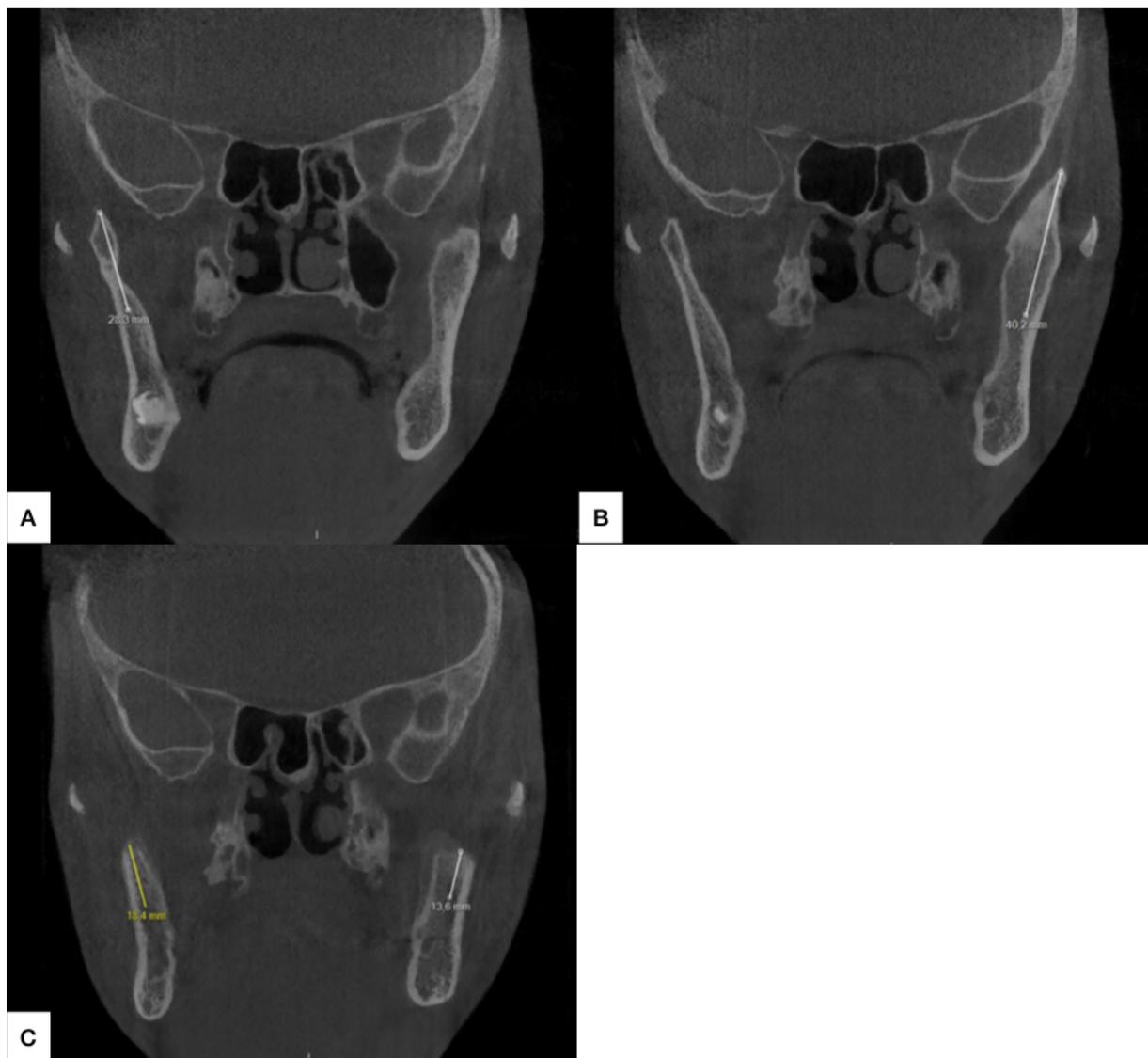


Figure 3 – Table 1

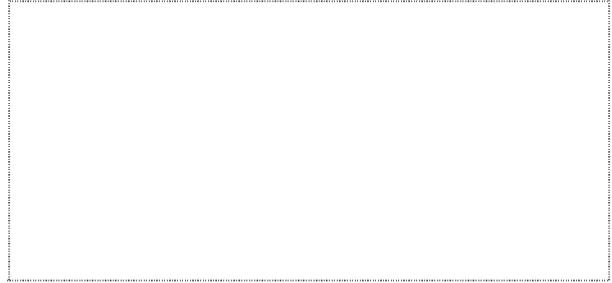

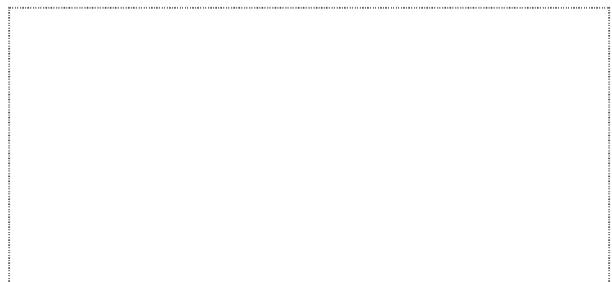

Titre de Thèse : Contrôle de l'ouverture buccale après coronoïdectomie chez les patients atteints de la maladie de Langenbeck ou de Jacob. Une étude rétrospective de 20 cas.

RESUME (10 lignes)

Les maladies de Langenbeck et de Jacob sont des causes rares de limitation progressive de l'ouverture de la bouche, causée par l'hypertrophie du ou des coronés sur l'os zygomatique. Cette étude rétrospective a porté sur vingt patients présentant une limitation de l'ouverture de bouche et ayant subi une coronoïdectomie. Contrairement à la littérature où l'on retrouve des taux de récurrence allant de 2 à 12%, le suivi postopératoire de ces patients a montré qu'aucune récurrence clinique n'était survenue. Le point commun de ces vingt patients était de poursuivre une physiothérapie efficace. Bien que le traitement standard de ces affections soit la coronoïdectomie, il semble important de considérer le rapport bénéfice/risque du patient et de n'opérer que si la limitation de l'ouverture buccale entraîne une réelle souffrance clinique pour la qualité de vie du patient.
